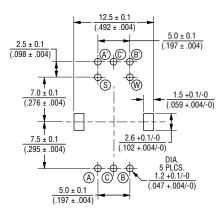

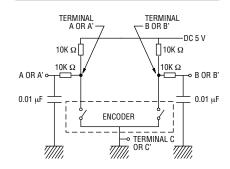
Recommended PCB Layout
