

Honeywell Announces Obsolescence of VPX1E Series Valve Position Indicators

Honeywell is announcing an option to buy the VPX1E Series Valve Position Indicators for the last time before its obsolescence (“Last Time Buy”). All models will have a direct replacement in the VPX1C line of switches. Honeywell values its customers and realizes that incorporating products with a slightly different part number may require time for transition. Thus, Honeywell is facilitating a Last Time Buy for its customers to help ease that transition.

During the transition time, customers are encouraged to place orders early for the parts that are being obsoleted.
